Overlay Reset: Categories in the overlay are reset when users edit their cookie consent settings.

Text Insertion Mismatch: When users type 2-3 sentences and attempt to insert a new sentence in front of the previous text, the positioning may get misaligned.

Mac Devices: The Cookie Consent Manager user interface does not render properly in the Safari browser.
