What's New

Segrite Data Privacy 2.3.3 includes the following new features and enhancements.

Visual Markers

Visual Markers is a special sign, tag that alerts the user to the privacy sensitivity of the data they are handling. This makes it easier for users to spot and manage privacy-related events in the app. This feature is currently supported only for **SharePoint**.

Data Breach Notification

Introduced a comprehensive data breach notification feature that includes incident logging, customizable notification templates, and automated alerts. This ensures timely and consistent communication with stakeholders when a privacy breach occurs, helping organizations stay compliant and respond quickly to incidents.

Bhashini Integration

- Support for 22 Indian languages translation of cookie banner text and consent notices.
- As a government-backed initiative, Bhashini ensures inclusivity, accessibility, and wider reach while strengthening trust and compliance with local privacy requirements.

Consent Management Enhancement

- **Comprehensive Report** with fields such as consent ID, data principal ID/type, form name, status, country, org unit, channel, expiry date, data received, and language.
- **Interactive Dashboard** providing charts and graphs for visual representation of consent data.
- Automated consent form updates/Minified Script Integration where any form version changes are automatically reflected on customer websites without code updates.

Other Enhancements

Classification Algorithm Improvements

Columns associated with multiple classifiers now display each classifier along with its confidence score (High or Low). This enhancement improves transparency and helps users identify which classifier best matches the expected sensitive data.

Support for PAC file-based Proxy

The product now has support to PAC file-based proxy to route traffic through the defined proxy and block URLs as specified, ensuring communication adheres to configured rules and restrictions. This release supports cloud deployment only.

Modular Licensing Enhancements

Modules are now accessible based on the assigned License Edition, ensuring users receive features aligned with their license type. Cookie consent, consent management and breach notification are now license controlled.

Known Issues

Here are some of the known issues in version 2.3.3.

- Visual Marker only supports files up to 4MB in size.
- In the Consent Report Log section, applying more than two filters may result in inaccurate output. The system works as expected with maximum two filters only.
- Confidence levels are not shown when using CSV or unstructured database files as the data source, for both current and additional classifiers.
- Confidence levels may be missing or inaccurately labeled (not labeled as High) when using skewed classifiers, leading to inconsistent communication across classifier types.
