What's New

Seqrite Data Privacy 2.3.4 includes the following new features and enhancements.

Support for Manual and PAC file-based Proxy

The product now supports both **Manual** and **PAC file-based proxy configurations**, along with **centralized proxy settings** for on-premises deployments. This enhancement allows traffic to be routed through the defined proxy and enables URL blocking as specified, ensuring all communication adheres to configured rules and restrictions.

Previously, proxy settings were managed through a separate module. With the redesign, they can now be configured **directly within the Deployment screen**, streamlining the setup process and improving usability.

Licensing Banner/ License Expire Banner

Introduced a banner notification for license expiry. This banner is displayed across all screens within the relevant module, ensuring that users are informed about the status of their license. By providing clear and consistent visibility, this feature helps prevent unexpected interruptions and supports timely renewal actions.

Country Widgets in Consent Dashboard

Added **Consent Rate by Country** widgets in the **Consent Dashboard** to display the country of origin for each consent.

Visual Marker Enhancement

- **Sensitivity Levels:** Users can now select a specific sensitivity level for their documents (Confidential, Protected, Private, Public). Previously, all levels were applied by default. This enhancement gives users more control over document sensitivity.
- **Header/Footer Option:** Added a checkbox to let users choose whether to overwrite existing headers and footers with Visual Marker.

Improved Oracle Scan Performance

Improved structure scanning reduces time for large datasets, enabling faster queries and improved performance with larger data operations on oracle.

Enhanced Data Summary Report

Introduced an enhanced classifier details page that improves transparency and usability:

- Number of classifiers associated with a column are now displayed together. Users can now click on any classifier to view its detailed information.

- Each classifier is accompanied by its confidence level (High or low), giving users clear visibility into the reliability of each classification.
- Classifier list can be filtered based on classifier name, making it easier to narrow down and focus on the most relevant matches.
- Column names have been renamed — Table is now referred to as **Collection**, and Column is now referred to as **Key**.

Introduced Preference Center

Preference Center allows users to manage their data consent and preferences in one place. It has two tabs:

- **Current Preferences:** Shows users their current active preference and allows them to modify their consent choice.
- **Preference History:** Shows historical record of consent submitted and any changes done to consent preferences by the user in the past.

Editing Enhancement in Consent Form

Once the consent form is published, any modifications made to it will now prompt users to mark the change as either **Breaking Change** or **Non-Breaking Change**.

- **Breaking Change:** When a change is marked as **Breaking Change**, all previously submitted consent for the affected statement become invalid. Users must re-submit their consent for that statement.
- **Non-Breaking Change:** When a change is marked as **Non-Breaking Change**, previously submitted consent remains valid and no resubmission is required from users.

Introduced API Auth Credentials for Consent Form Module

Added support for secure API authentication in the Consent Form module. This enables controlled and secure access to consent API calls. Improves access control, security, and integration flexibility.
